# North East London Integrated Care System Research Engagement Network (NEL ICS REN) training for public contributors

Later this year, the Research Engagement Team will deliver two half day PPIE/ research champion training workshops. Funded by NHS England, these sessions will be co-designed and co-delivered by a working group comprised of PPIE leads from BH, QM and CRN North Thames, REN partners, and experienced public contributors. The champions in attendance will be made up of people from our existing database, new registrations from the REN events held earlier this year, and attendees at our International Clinical Trials Day in May. We hope these sessions will help us to develop a community of research-ready public contributors who are able to apply their lived experiences and expertise to the wide range of public involvement opportunities we offer. The training is also open to existing public contributors who you feel may benefit from a formal introduction to PPIE or dedicated learning opportunity. Please let us know before **Friday 9**th **August** if there any public contributors you would like to join these sessions.

At each event, there will be a 'PPIE marketplace' of researchers who are looking to find people for their public involvement activities. If you are looking for public contributors to join your advisory group or take part in a focus group or workshop and would like to be a part of our training sessions, we would love to hear from you! 


# **Patient Research Champions (PRCs)**

We have recently met with several new prospective Patient Research Champions. Most of these individuals are already registered with the Volunteers Service and are ready to begin a new role supporting our research efforts. There are many ways a PRC can help you and your team, but they ultimately help maximise our patients' experience of taking part in our research. # Patient Research Experience Survey (PRES) 24-25

We have made a solid start to our 2024-25 PRES campaign, having recorded 113 responses so far against our target of 335. The graph below shows all the responses for all CRN North Thames organisations to date.



After a disappointing return last year, we are looking to bounce back and surpass this year's target of 335. There are a variety of resources available to you that can help you in administering the survey:

- The PRES <u>e-Learning module</u> on for staff members delivering the survey. This may be particularly useful for researchers who are new to delivering PRES.
- The <u>PRES Video (With Music)</u> produced by CRN Wessex is a 2-minute clip that summarises PRES and why we use it.
- CRN North Thames have produced a <u>QR code slip aid</u> for adult and children's PRES surveys. This allows research teams to input the required study identifiers (site name, study title, CPMS or IRAS) to generate a unique QR code for the study. Patients can scan the QR code and complete the survey without having to input the study identifiers themselves, ensuring the results are always mapped back to the appropriate team. # **Blocked websites**

We previously communicated that there are several websites we use and signpost our colleagues to have been blocked from Barts accounts, including NIHR Learning for Involvement (<a href="www.learningforinvolvement.org.uk">www.learningforinvolvement.org.uk</a>). Having alerted ICT to this problem, the problem is now resolved but we will also be keeping a close eye to ensure it does not reoccur. If you discover any additional websites are blocked, please log it with ICT and notify the Research Engagement team.

# **INVOLVE** website closing

NIHR have recently announced the closing down of the INVOLVE site, effective as of 23rd July 2024. INVOLVE ceased to exist in 2020; since then, the site has not been used much and the lack of updates since then cause a security risk. If you still use INVOLVE for any resources, please ensure you check and update them ahead of the site closure on 23<sup>rd</sup> July.
